## The Global Economic Outlook

Jay Bryson is a managing director and global economist at Wells Fargo Securities, where he provides analysis on macroeconomic developments in the major economies of the world. He is based in Charlotte, N.C.

Before joining Wells Fargo in 1998, Jay was an economist in the Division of International Finance at the Federal Reserve Board in Washington, D.C. From 1989 to 1992 he was an assistant professor of economics at the University of Alabama. Jay has also lectured on international economics and macroeconomics at the School for Advanced International Studies at Johns Hopkins University and at Georgetown University.

Jay has published in academic and popular economic journals, and his comments on the economy regularly appear in the Wall Street Journal, the New York Times, and USA Today. He also makes frequent appearances on CNBC and Bloomberg TV. Jay is a member of the American Economic Association and the Charlotte Economics Club.

He is also a member of the National Association for Business Economics and served on its board of directors from 2010 to 2013.

Jay received his B. A. and Ph.D. degrees in economics from the University of North Carolina at Chapel Hill.

# **FEI Houston Scholarship Foundation Update**

Although the Chapter's scholarship foundation was founded in 2003, and received favorable determination from IRS as 501 (c)(3) on November 3, 2003, the Houston chapter has been supporting deserving students in southeast Texas since about 1970. Currently, each student selected from the twelve schools is awarded \$4,000. The philosophy is to target very highly qualified students at least of junior year status that have "fallen through the crack" and provide the funds needed for them to graduate. The student group continues to average about 85% minorities. Cumulative scholarship awards to students now well exceed \$400,000, most of which has been awarded via the Foundation.

These awards are supported by donations from the chapter, its officers, and members – as well as community-minded corporate donors. Through the generosity of contributors, the Foundation now has accumulated assets over \$400,000. Donor recognition is provided via the chapter and various brochures for the Foundation and for AHD. While the record level of assets is a significant achievement, this is still short of the goal for earnings to fund scholarships for the future.

The 2014 Academic Honors Day was held at the Houston Branch of the Federal Reserve Bank and was quite a success. Pictures were featured in an earlier newsletter. Reflecting on near term accomplishments, the Foundation will hold the third annual dean's luncheon on November 21st. This has proved to be quite a success, especially in concert with AHD. At least two of the students have landed internships with FEI members this past year.

We are also very close to launching the Foundation web site in upcoming weeks. Not only will this provide a forum for governance and documenting the various events, but also will allow for use of credit card donations – something that had to be discontinued years ago for technical reasons. We hope to provide members with formal announcement and instructions within the next 4-5 weeks.


